1. OVERVIEW

- 1.1. This mobile application (“App”) is owned and operated by iAPPS Pte Ltd. Throughout the app, the terms “we”, “us” and “our” refer to iAPPS Pte Ltd. iAPPS Pte Ltd offers this App, including all information, tools and services available from this App to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.
- 1.2. By visiting our App and/ or purchasing something from us, you engage in our “Service” and agree to be bound by the following terms and conditions (“Service Policy”, “Terms”), including those additional terms and conditions and policies referenced herein and/or available by hyperlink.
