

## RAMADAN SPECIAL

### SGD 0 transfer fee and 5% bonus for remittances to bKash account

Welcome the month of Ramadan with SLIDE and bKash.

Send money directly, securely, and easily to a bKash wallet in Bangladesh with SLIDE Member app.

1. The SGD 0 transfer fee only applies to SlideSG remittance transactions to a bKash account in Bangladesh via SLIDE Member App.
2. The 5% bonus is based on the remitted amount, and will only be given to active bKash accounts that can accept remittances.
3. The maximum bonus amount per transaction is 250 BDT, and the maximum bonus amount during the campaign period is 3000 BDT.
4. The Promotion is available from 14 June 2018 to 20 June 2018 (the "**Promotion Period**"), both dates inclusive.
5. Under the Promotion, and subject to these Terms and Conditions, eligible participants who signed up for SLIDE for the first time during the Promotion Period shall be entitled to receive a First Time FREE Remittance and reward their receivers with an extra 5% bonus ("**Reward**").

### **Eligibility**

1. To be eligible for the Promotion, the participant must register for SlideSG remittance service, which is provided under the license RA01512, after signing up for a SLIDE Account
2. The participant must comply at all times with the terms and conditions governing the use of SLIDE Member App, including, but not limited to, the SLIDE Terms and Conditions and Send Overseas Terms and Conditions (both of which may be accessed at <https://slide.sg/terms/>)
3. The First Time FREE Remittance Voucher is not exchangeable for cash.
4. SlideSG reserves the right to disqualify any one or more of the eligible participants, if:
  - a. the participant is determined, in SLIDE's sole discretion, to be ineligible for any reason whatsoever, or,
  - b. at any time, SLIDE, at its sole and absolute discretion, suspects any fraud in relation to, and/or misuse of, the eligible participant's SLIDE Account, or,
  - c. the phone number which is registered in respect of the eligible participant's SLIDE Account is for any reason changed (whether by the participant or any other person, with or without the consent or knowledge of the participant) during the Promotion Period.

By accepting the Reward, the eligible participant agrees that SLIDE may use the eligible participant's personal details, photographs or any likeness for advertising and promotional purposes without further consideration. However, SLIDE is under no obligation whatsoever to disclose the identity of the participant or to publish the same for any reason at any point of time.

SLIDE reserves the right to determine at its sole and absolute discretion all matters arising out of or in connection with the Promotion, including the participants' eligibility and the applicable criteria. SLIDE's determination of all matters relating to this Promotion shall be final and binding and no appeal or objection on any grounds will be entertained.
