1. The Black Friday Special (the “**Promotion**”) only applies to SlideSG remittance transactions to Indonesia and Philippines via SLIDE Member App.
2. The Promotion is available from 23 November 2018 to 26 November 2018 (the “**Promotion Period**”), both dates inclusive.

Eligibility

1. To be eligible for the Promotion, the participant MUST be registered for SlideSG remittance service, which is provided under the license RA01512, after signing up for a SLIDE Account. Click here (<https://bit.ly/2OSxkve>) for a guide on how to register for SlideSG remittance service.
2. The participant must comply at all times with the terms and conditions governing the use of SLIDE Member App, including, but not limited to, the SLIDE Terms and Conditions and Send Overseas Terms and Conditions (both of which may be accessed at <https://slide.sg/terms/>)
3. SlideSG reserves the right, in SLIDE’s sole discretion to disqualify any eligible participants, if:
 - a. the participant is determined to be ineligible for any reason whatsoever, or,
 - b. at any time, SLIDE suspects any fraud in relation to, and/or misuse of, the eligible participant’s SLIDE Account, or,
 - a. the phone number which is registered in respect of the eligible participant’s SLIDE Account is for any reason changed (whether by the participant or any other person, with or without the consent or knowledge of the participant) during the Promotion Period.
2. By accepting the Reward, the eligible participant agrees that SLIDE may use the eligible participant’s personal details, photographs or any likeness for advertising and promotional purposes without further consideration. However, SLIDE is under no obligation whatsoever to disclose the identity of the participant or to publish the same for any reason at any point of time.

SLIDE reserves the right to determine at its sole and absolute discretion all matters arising out of or in connection with the Promotion, including the participants' eligibility and the applicable criteria. SLIDE's determination of all matters relating to this Promotion shall be final and binding and no appeal or objection on any grounds will be entertained.
