

## Terms and Conditions for 7-Eleven \$0.50 Cashback Promotion

1. The SLIDE \$0.50 Cashback Promotion (the "Promotion") is organised by iAPPS Pte Ltd ("iAPPS") and subject to these Terms and Conditions. By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of iAPPS, which shall be final and binding in all respects.
2. The Promotion is only available for SLIDE Member App users from 8 May 2019 to 30 June 2019 (the "Promotion Period"), both dates inclusive. Under the Promotion, and subject to these Terms and Conditions, eligible participants shall be entitled to receive \$0.50 cashback in their respective SLIDE Wallets when they top up at any 7-Eleven stores.
3. SLIDE Member App users can top up their SLIDE Wallet with a minimum amount of \$10 and maximum amount of \$500 per top up at any 7-Eleven stores.

### **Eligibility**

4. To be eligible for the Promotion, the participant must:
  - a) have a SLIDE Member App Account ("SLIDE Account"), which must be and remain valid and must not for any reason be terminated and/or suspended during the Promotion Period;
  - b) top up his/her SLIDE Wallet at any 7-Eleven stores islandwide.
  - c) comply at all times with the terms and conditions governing the use of SLIDE Member App, including, but not limited to, the SLIDE Terms and Conditions and Send Overseas Terms and Conditions (both of which may be accessed at <https://slide.sg/terms/>)
5. The Cashback will be available in the eligible participant's SLIDE Wallet immediately after the top up and is not exchangeable for cash.
6. iAPPS reserves the right to disqualify any one or more of the eligible participants, if:
  - a. the participant is determined, in iAPPS's sole discretion, to be ineligible for any reason whatsoever, or,
  - b. at any time, iAPPS, at its sole and absolute discretion, suspects any fraud in relation to, and/or misuse of, the eligible participant's SLIDE Account, or,
  - c. the phone number which is registered in respect of the eligible participant's SLIDE Account is for any reason changed (whether by the participant or any other person, with or without the consent or knowledge of the participant) during the Promotion Period.
7. By participating in the Promotion, the eligible participant agrees that iAPPS may use the eligible participant's personal details, photographs or any likeness for advertising and promotional purposes without further consideration. However, iAPPS is under no obligation whatsoever to disclose the identity of the participant or to publish the same for any reason at any point of time.

## **General**

8. By participating in the Promotion, the participants consent to iAPPS' collection, holding, storage, use, processing, transfer, disclosure and/or reporting (whether directly or indirectly) to any relevant third party, of the participants' personal data and/or information provided to iAPPS, including but not limited to, for the purposes of administering the participants' registration, organizing and promoting the Promotion, or otherwise for purposes relating to the Promotion; and the participants further consent and acknowledge that the participants' personal data and/or information (i) will also be processed in line with SLIDE's privacy statement available <https://slide.sg/wp-content/uploads/2017/03/SLIDE-Service-Policy.pdf>; and (ii) may be used in accordance with iAPPS' policies, terms and conditions or notices made available by iAPPS from time to time.
9. iAPPS reserves the right to, at its sole and absolute discretion, vary, modify and amend any of these Terms and Conditions and/or to suspend, discontinue or terminate the Promotion at any time without prior notification, or liability to any party.
10. iAPPS reserves the right to determine at its sole and absolute discretion all matters arising out of or in connection with the Promotion, including the participants' eligibility and the applicable criteria. iAPPS' determination of all matters relating to this Promotion shall be final and binding and no appeal or objection on any grounds will be entertained.
11. Unless otherwise stated, this Promotion is not valid with other offers, discounts, rebates, vouchers, privileges or promotions.
12. In the event of any inconsistency between these Terms and Conditions and any brochure, marketing or promotion material relating to the Promotion, these Terms and Conditions shall prevail.
13. By participating in the Promotion, each participant agrees to fully and effectively indemnify, defend and hold harmless iAPPS from and against any and all rights, demands, claims, causes of action, losses, damages, costs and expenses whatsoever that the participant may have, or which may arise, whether in whole or in part, and whether directly or indirectly, due to or arising out of participation in the Promotion. These obligations will continue to survive the expiry or termination of the Promotion.

To the extent permitted by law, iAPPS shall not be liable in any way to any participant or any other person for any losses or damages of any kind, including but not limited to direct, indirect, incidental, consequential, special or punitive damages arising out of or in connection with the Promotion, including without limitation, from any late or non-notification, any error in computing chances, any technical, hardware or software breakdown, malfunction or defects, failed delayed or incorrect transactions, lost or unavailable network connections or any notice that is lost or misdirected.

15. These Terms shall be subject to and construed in accordance with the laws of Singapore and the participants hereby submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
16. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
