

## TERMS and CONDITIONS

### SGD 0 remittance fee for remittance to Philippines

Promotional SGD 0 remittance fee to Philippines (the “Promotion”) is organized by SlideSG Pte Ltd (“SLIDE”) in collaboration with CIMB Bank Berhad, Singapore Branch (“CIMB”) and subject to these Terms and Conditions. By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions.

1. The SGD 0 remittance fee only applies to SlideSG remittance transactions to the Philippines via SLIDE Member App.
2. The Promotion is available from 1 July 2019 to 31 December 2019 (the “**Promotion Period**”), both dates inclusive.
3. Under the Promotion, and subject to these Terms and Conditions, eligible SLIDE customers who have made any successful remittance transactions to Philippines via SLIDE MEMBER app during the Promotion Period shall be entitled to the Promotion Fees as shown below:

### Eligibility

1. To be eligible for the Promotion, the participant MUST be registered for SlideSG remittance service, which is provided under the license RA01512, after signing up for a SLIDE Account. If not registered yet, click here ( <https://tinyurl.com/philippines> ) to see the guide on how to register for remittance.
2. To be eligible for the Promotion, the participant MUST link and have their SLIDE wallet topped up via CIMB account, with a minimum of **SGD 350**.
3. The participant must comply at all times with the terms and conditions governing the use of SLIDE Member App, including, but not limited to, the SLIDE Terms and Conditions and Send Overseas Terms and Conditions (both of which may be accessed at <https://slide.sg/terms/>)
4. SlideSG and CIMB reserve the right, in their sole discretion to disqualify any eligible participants, if:
  - a. the participant is determined to be ineligible for any reason whatsoever, or,
  - b. at any time, SLIDE or CIMB suspects any fraud by any participant in relation to, and/or misuse of, the eligible participant’s SLIDE Account or CIMB account, or,
  - c. the phone number which is registered in respect of the eligible participant’s SLIDE Account is for any reason changed (whether by the participant or any other person, with or without the consent or knowledge of the participant) during the Promotion Period.

5. By participating in this promotion, the eligible participant agrees that SLIDE and CIMB may use the eligible participant's personal details, photographs or any likeness for advertising and promotional purposes without further consideration. However, SLIDE and CIMB is under no obligation whatsoever to disclose the identity of the participant or to publish the same for any reason at any point in time.

## **General**

By participating in the Promotion, the participants consent to SLIDE and CIMB's collection, holding, storage, use, processing, transfer, disclosure and/or reporting (whether directly or indirectly) to any relevant third party, of the participants' personal data and/or information provided by them, including but not limited to, for the purposes of administering the participants' registration, organizing and promoting the Promotion, or otherwise for purposes relating to the Promotion; and the participants further consent and acknowledge that the participants' personal data and/or information (i) will also be processed in line with SLIDE's privacy statement available <https://slide.sg/wp-content/uploads/2017/03/SLIDE-Service-Policy.pdf>; and (ii) may be used in accordance with SLIDE's policies, terms and conditions or notices made available by SLIDE from time to time.
7. SLIDE and CIMB reserves the right to, at its sole and absolute discretion, vary, modify and amend any of these Terms and Conditions and/or to suspend, discontinue or terminate the Promotion at any time without prior notification, or liability to any party.

SLIDE and CIMB reserves the right to determine at its sole and absolute discretion all matters arising out of or in connection with the Promotion, including the participants' eligibility and the applicable criteria. SLIDE and CIMB's determination of all matters relating to this Promotion shall be final and binding and no appeal or objection on any grounds will be entertained.
9. Unless otherwise stated, this Promotion is not valid with other offers, discounts, rebates, vouchers, privileges or promotions.
10. In the event of any inconsistency between these Terms and Conditions and any brochure, marketing or promotion material relating to the Promotion, these Terms and Conditions shall prevail.

By participating in the Promotion, each participant agrees to fully and effectively indemnify, defend and hold harmless SLIDE and CIMB from and against any and all rights, demands, claims, causes of action, losses, damages, costs and expenses whatsoever that the participant may have, or which may arise, whether in whole or in part, and whether directly or indirectly, due to or arising out of participation in the Promotion. These obligations will continue to survive the expiry or termination of the Promotion.

13. These Terms shall be subject to and construed in accordance with the laws of Singapore and the participants hereby submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
